**PART I. GENERAL EXPECTATIONS**

The Santa Cruz Elementary District 28 agrees to implement the following statutory requirements:

**PART II. DESCRIPTION OF HOW DISTRICT WILL IMPLEMENT REQUIRED DISTRICT WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS**

1. The Santa Cruz Elementary District 28 will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of the ESEA: Meet with parents at the beginning of each year to help us develop our Parent involvement plan.

The Santa Cruz Elementary District 28 will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A school. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
  - A. We will give this evaluation during our third quarter parent teacher conferences. We will share this information with the parents at our parent teacher committee meetings and on our school website [www.sced28.com](http://www.sced28.com). Surveys would be given out by teachers.
6. The Santa Cruz Elementary District 28 will build the schools’ and parent’s capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:

- the requirements of Part A,
- how to monitor their child’s progress, and
- how to work with educators:

These items are discussed at parent teacher conferences, open house, at personal conferences with parents about their levels in English and in child study and SPED meetings and annual Title One meetings.

- B. The school district will, with the assistance of its school to provide materials and training to help parents work with their children to improve their children’s academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by: providing training when it is asked for and agreed on by a committee or group.
- C. The school district will, with the assistance of its school and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by: providing agenda items at teacher meeting to meet these needs.
- D. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand: by placing them on our marquee, monthly calendar, monthly classroom website updates, regular notices, and translating into Spanish.


- training parents to enhance the involvement of other parents;


