2. Discuss Current financial district status and possible outcomes for SY 24-25

Mrs. Romero showed a presentation to the parents from ASBA where Congress and Legislation have be talking about the Aggregating Spending Limit, this is happening Statewide, Countywide, Nationwide, due to this, many schools were contemplating on closing in the month of April of last year. If Legislation brings Aggregating Spending Limit back, it will affect our school district with \$300,000 dollars for the following school year. Mrs. Romero told parents about how she knows that parents are concerned about their children's education and explained what the Roll of our Governing Board is, that they do not get paid for being on the Governing Board , they are community members interested in the kid's education. Mrs. Romero explained how Little Red's budget situation started about two years before COVID, but the district was able to keep going due to ESSER Funds that are no longer available. Another huge factor for our budget is the low student population in our school district. She stated that many schools are going through the same situation, there are many vouchers, school choices, Charter Schools, Online Public Schools homeschooled students. Many parents are working from home and have decided to homeschool their

children. Many factors taking place. She stated that Board Member have always been informed about the school's Financial Situation. Mrs. Romero talked about the things that have been done to cut spending; reduced teacher aide hours, stopped paying for students snack, bus drivers hours were cut, hired another food service company. Mrs. Romero also talked about the budget cuts for SY 24-25 will include frozen salaries, continue not to pay for snacks, insurance premiums capped, and contracted food service. Mrs. Romero presented the different scenarios for multi-leveled classrooms and the advantages of having combined classes for the students. The presentation included additional budget cut scenarios and the savings amount for each one.

Discussion took place of multi-level classrooms including possible outcomes to help the districts financial status. Student enrollment numbers per class was discussed and the possible solutions such as going to small schools adjustment.
